4 Information on the public procurement procedure

4.1 Type of public procurement procedure: Open procedure

4.2 Estimated value of public procurement: KM 112,000.00 (VAT excluded) as follows

- LOT 1 - Spare parts for lifts and chairlifts of the manufacturer POMA, the estimated value of KM 82,000.00, \notin 41,925.00, the original parts or equivalent with written consent of the machinery manufacturer;

- LOT 2 - Spare parts for chairlifts of the manufacturer LEITNER, the estimated value of KM 30,000.00, \in 15,338.00, original parts or equivalent with written consent of the machinery manufacturer.

4.3. Type of public procurement contract: Open Bidding Procedure for procurement of goods - spare parts for snow-grooming machines of the manufacturers POMA and LEITNER.

4.4. Framework agreement is not envisaged.

4.5. The contract period: the contract period for procurement of goods is one year from the date of conclusion of the contract.

INFORMATION ON THE SUBJECT OF PROCUREMENT

5. Description of the subject of procurement

The subject of this procedure is the procurement of goods - spare parts for inclined transport / lifts and chairlifts of the manufacturer POMA and the manufacturer LEITNER based on the

needs of the Contracting Authority, provided by the financial plan for 2015. JRJN - 34900000-6.

6. Division into lots

The subject of procurement is divided into lots as follows: LOT 1 - Spare parts for lifts and chairlifts of the manufacturer POMA LOT 2 - Spare parts for chairlifts of the manufacturer LEITNER.

Bidders may bid for one lot, for several lots or for all lots. The bid is submitted for each lot separately (in separate envelopes). The bid within the lot must contain all the items in the manner specified by the technical specification.

The bidder may submit only one bid for each lot. All bids of the bidders who submit or participate with several bids, only individually or within a group of bidders for the same lot will be rejected for that lot.

7. Quantities of the subject of procurement by lots

- LOT 1 Spare parts for lifts and chairlifts of the manufacturer POMA according to the technical specification in the Bid Pricelist Form (Annex II)
- LOT 2 Spare parts for chairlifts of the manufacturer LEITNER according to the techical specification in the Bid Pricelist Form (Annex II).

8. Place of delivery of goods

Place of delivery of goods for all LOTs is the Technical base on Jahorina. Upon the conclusion of the contract the selected bidder shall deliver the subject goods in the Technical base on Jahorina on the basis of orders and requests for delivery of goods by the Contracting Authority.

9. Deadline for delivery of goods

Delivery of goods is carried out successively according to the needs on the basis of orders and requests for goods delivery of the Contracting Authority, within the deadline stipulated by the selected bidder in the bid, point 3 of the Bid Submission Form.

ELIGIBILITY REQUIREMENTS

10. Eligibility requirements

In order to prove personal ability the bidder is required to prove that:

a) in criminal proceedings it has not been convicted by a final judgment for criminal offenses of organized crime, corruption, fraud or money laundering, in accordance with the applicable regulations in Bosnia and Herzegovina or the country in which it is registered;

b)it is not bankrupt or subject to bankruptcy proceedings, unless there is a valid decision confirming the bankruptcy plan, or is subject to liquidation proceedings, or is in the process of suspension of business activities, in accordance with the applicable regulations in Bosnia and Herzegovina or in the country where it is registered;

c) it has fulfilled obligations relating to the payment of pension and disability insurance and health insurance, in accordance with the applicable regulations in Bosnia and Herzegovina or in the country where it is registered;

d) it has fulfilled its obligations relating to the payment of direct and indirect taxes, in accordance with the applicable regulations in Bosnia and Herzegovina or the country in which it is registered.

In order to prove the requirements set out in points a) to d) the Bidder shall submit a completed and certified by a competent authority statement which is an integral part of the tender documentation. The statement may not be older than 15 days from the date of submission of the bid.

If the bid is submitted by a group of bidders, each member of the group is required to submit a certified statement.

Bidder that is selected as the best in this public procurement procedure shall submit the following evidence in order to prove facts confirmed in the statement as follows:

a) an extract from the criminal records of the competent court that it has not been convicted in the criminal proceedings by a final judgment for criminal offenses of organized crime, corruption, fraud or money laundering, in accordance with the applicable regulations in Bosnia and Herzegovina or the country in which it is registered;

b) a statement or confirmation from the register in which it is registered that it is not bankrupt or subject to bankruptcy proceedings, unless there is a valid decision confirming the bankruptcy plan, or is subject to liquidation proceedings, or is in the process of suspension of business activities, in accordance with applicable regulations in Bosnia and Herzegovina or the country in which it is registered;

c) certificate by the competent tax office or if a bidder is not registered in Bosnia and Herzegovina, certificate or extract from the register on the basis of which it can be determined that it regularly meets obligations for pension and disability insurance and health insurance.

d) the relevant certificate or certificates of institutions on duly paid direct and indirect taxes.

In the event that the bidders have concluded an agreement on rescheduling of obligations or

deferred payment, based on contributions for pension and disability insurance, health insurance, direct and indirect taxes, they are required to submit a certificate from the competent institution or institutions confirming that the bidders duly settle their rescheduled liabilities as per scheduled timetable. If the Bidder concluded an agreement on rescheduling of liabilities or deferred payment of duties and made only one payment of obligations, immediately before the bid submission, it shall not be considered to fulfill its obligations within the envisaged timeframe and such a Bidder shall not be eligible in this public procurement procedure.

The evidence that is required to be delivered by the selected bidder must include a certificate that at the time of the bid submission it met the requirements of the tender documentation. Otherwise it will be deemed that it has given a false statement. The Bidder shall submit the evidence of fulfillment of the requirements within 5 days of receipt of notification of the results of the public procurement procedure. The evidence submitted by the selected bidder may not be older than three months, counting from the moment of submission of the bid. The selected bidder must fulfill all requirements at the time of submission of the bid, otherwise it will be considered to have made a false declaration under Article 45 of the Law.

If the bid is submitted by a group of bidders, each member of the group must meet the requirements in terms of personal ability and evidence is submitted for each member.

The Contracting Authority shall disqualify bidders in this public procurement procedure if it can prove that the bidder has been guilty of serious professional misconduct in the last three years, but only if it can prove in any way, especially significant and/or defects that are repeated in the execution of the essential requirements of the contract that have led to its early termination (e.g., evidence of early termination of the previous contract for failure to fulfill obligations in accordance with the Law on Obligations), damage (final judgment of a competent court for the damage suffered by the Contracting Authority), or other similar consequences as the result of intent or negligence of such a business entity (evidence in accordance with the existing regulations in Bosnia and Herzegovina).

12. Other eligibility requirements

All bidders are required to submit the decision on registration for the subject business activity. If the bid is submitted by a group of bidders, all members of the group together must be registered for performing of activities subject to procurement or part of the subject of procurement.

INFORMATION ON THE BID

13. Content and preparation of the bid

The bid and all accompanying documentation shall be prepared in one of the official languages in Bosnia and Herzegovina, in Latin or Cyrillic alphabet and in the Enlish

language. When preparing a bid, the bidder must comply with the requirements and terms of the tender documents. The bidder must not add or modify the text of the tender documents.

The bid shall contain at least:

- a) Bid Submission Form Annex 1; Attachment I;
- b) Bid Pricelist Form Annex II;
- c) Declaration on fulfillment of conditions referred to in Article 45 paragraph (1) pointsa) to d) of the Law on Public Procurement Annex III;
- d) Decision on registration (uncertified copy) IV;
- e) Affidavit of the bidder under Article 52 of the Law on Public Procurement Annex V;
- f) Draft Contract Annex VI;

14. The method of bid submission

Regardless of the submission method, the bid shall be received by the Contracting Authority at the address given in the tender documents, until the date and time specified in the procurement notice and tender documentation. All bids received after that time are untimely and as such, will be returned unopened to the bidder.

Tenders must be submitted to the protocol of the Contracting Authority or by mail to the address of the Contracting Authority, in a sealed envelope which bears on the front the following note:

"DO NOT OPEN" It is opened by the Commission. The back of the envelope shall bear the following: Name and address of the bidder

Bids shall be tightly bound in such a way as to prevent subsequent removal or insertion of pages. If the bid is made in two or more parts, each part is tightly bound in such a way as to prevent subsequent removal or insertion of pages. Parts of the bid such as samples, catalogs, storage media, etc.. which can not be bound shall be marked by the bidder with the name and listed in the table of contents as part of the bid.

Pages of the bid shall be numbered in a way to make the page number clearly visible. When the bid is made of several parts, the pages are numbered so that each subsequent part starts with a serial number which is the continuation of the page numbering with which the previous part ends. Guarantees as part of the bid are not numbered. If it contains printed literature, brochures, catalogs that have originally numbered pages, then these parts of the bid are not numbered further. The bid shall not be rejected if the bid pages are numbered in a way that provides numbering continuity, and it shall be considered as a minor deviation that does not materially alter or depart from the characteristics, terms and other requirements set forth in the procurement notice and tender documentation.

15. The method of submission of the shared documents when divided into lots

If the procurement is divided into several lots, the bidder who submits a bid for several lots shall be entitled to submit a statement of fulfillment of qualification requirements in one bid, the first one by the ordinal number of the lot for which the bid is submitted.

Bids for all lots for which the bidder bids are submitted in separate envelopes which must bear indication of the lot for which the bid is submitted.

A copy of the bid shall be submitted together with the original bid. In this case, it shall be clearly indicated as "original" and "copy" of the bid. In case of differences between the original and copy of the bid, the original bid shall be authentic.

16. Admissibility of alternative bid submission

The present procurement procedure does not provide for alternative bid submission. The alternative bid does not imply bid option.

17. Bid Pricelist Form from the Annex

Pricelist Form provided in Annex 2 of the tender documentation is prepared in accordance with the requirements of the tender documents and it forms an integral part of the tender documentation.

Bidders are required to submit a completed pricelist form for the bid in accordance with all the requirements that are defined and for all items that are contained in the form. In the event that the bidder fails to complete a form in accordance with the set requirements or for all the items that are listed, the bid shall be rejected.

If the Bid Pricelist Form contains multiple items, the bidder shall make a bid for all of the items, taking into account that the total sum of the prices of all items in the form cannot be 0.

18. Bid Pricing

The bid price includes all items from the bid price form.

The bid price is written in numbers and letters. The bid price is fixed.

The bid price is fixed.

The bid price shall state the bid price without VAT.

If the bidder is not a VAT payer, it does not show VAT and it enters 0.00 into the entry for the corresponding amount of VAT in the bid price form.

19. Bid currencies

The bid price is expressed in convertible marks (BAM) or Euros (\in).

The Contracting Authority stipulates in the tender documentation that the bid price may be expressed in foreign currency Euro (\in), i.e. the calculation of the bid price shall be made at the exchange rate of the Central Bank of BiH.

20. Criteria for the contract award

Criterion for the contract award is

The most economically advantageous bid - with the sub-criteria:

a) Price	. 90%
b)Payment term	. 10%

Price:

The bid with the lowest total price of the bid (Cmin) gets maximum points, i.e. 90 points. Number of points for the overall bid price - C – of other bids shall be calculated according to the formula:

the minimum offered price (in KM without VAT) C = ______ x the maximum number of points (90)

offered price (in KM without VAT)

Payment terms:

The bid with the longest number of days from the bid (Cmax) gets the maximum points, i.e. 10 points. Number of points for the term of payment from the bid - C – of other bids shall be calculated according to the formula:

offered period (in days) C = ______ x the maximum number of points (10)

the longest period (in days)

The shortest payment term is 15 days from the receipt of the invoice for the delivered goods.

Advance payments are 0 points, the advance in any proportion is 0 points.

In the event that in the process of procurement, two bidders and two bids have the same number of points, preference is given to the bid which, according to the criterion of price, offered a lower price, and the contract shall be awarded to such a bid.

21. Language and alphabet of the bid

Bids shall be submitted in one of the official languages in Bosnia and Herzegovina, in Latin or Cyrillic alphabet whereas foreign bidders may submit their bids in English language with translation in one of the official languages in BiH.

22. Bid validity

Tender documentation is valid for 90 days.

If a bidder does not specify the validity period in its bid, then it is considered that the validity period is the one that is specified in the tender documents.

In the event that the tender validity period is shorter than specified in the tender documents, the Contracting Authority shall reject such a bid in accordance with Article 60 (1) of the Law.

The Contracting Authority reserves the right to seek consent in writing for extension of bid validity period. If the bidder fails to submit a written consent, it is considered that it rejected the request of the Contracting Authority, and its bid shall not be considered in the further course of the public procurement procedure.

25. Draft contract with the basic contract elements

An integral part of this tender documentation is the draft contract with all the elements from the tender documentation. Bidders are required to submit the draft contract in which they entered the data from their bids and initial all pages of the draft contract.

26. Deadline for contract award decision

The Contracting Authority shall decide on the contract award to the best bidder or the cancellation of the public procurement procedure within the bid validity, but not later than 7 days from the date of expiry of the bid.

The Contracting Authority shall send the decision on the award to the best bidder to all bidders in the public procurement procedure within 3 days, and no later than 7 days from the date of the award decision or cancellation of procurement procedures electronically, or by mail.

27. Deadline, method and terms of payment to awarded bidder

Payment to the awarded bidder shall be in accordance with the bid, criterion b), successively upon deliveries during the term of the contract, the payment will be made upon receipt of invoices for deliveries made at prices quoted in the bid.

ADDITIONAL INFORMATION

28. The bid costs and overtaking of the tender documents

All costs of bid preparation and submission shall be borne by the bidder.

Tender documents may be obtained as follows:

- On the website of the Contracting Authority <u>www.oc-jahorina.com</u>. until 08 October 2015 at 14.00 H, with mandatory written notification to the Contracting Authority that the tender documents were downloaded, with the date and time of downloading of the tender documents. Bidders who download the tender documents **and fail to inform in writing the Contracting Authority to have downloaded it, shall be deemed to have not taken the tender documents and their bids will be rejected as inadmissible;**

or on the basis of the request of the bidder:

- In person at the premises of the Contracting Authority;
- By E-mail, or by mail with return receipt.

29. Correction and/or modification of the tender documents, seeking clarifications

The Contracting Authority may, at any time, but no later than 10 days before the deadline for submission of bids, for justifiable reasons, either on its own initiative or in response to a request for clarification of the undertaking, either by order of the Office of Appeals, amend the tender documents. All modifications to the tender documentation shall be notified to all potential bidders that are known to have taken the tender documents.

In the event that the amendments to the tender documents are such as to require additional time to prepare bids, the deadline for submission of bids shall be accordingly extended, but not less than 7 days.

In the case of giving clarifications at the request of the business entity, the Contracting Authority shall inform by the written response all potential bidders who took over tender documentation in one of the ways specified in point 35 of the tender documents, but the response for the clarification will not mention the name of the business entity who sought clarification. Request for clarification may be lodged no later than 10 days before the deadline for receipt of bids. The Contracting Authority shall, within 3 days, and no later than 5 days before the expiry of the deadline for submission of bids submit a written clarification to all potential bidders.

30. Confidentiality of records of business entities

Bidders who submit bids that contain information that is confidential, shall indicate confidential data along with the legal basis on which the data is considered confidential.

The following data shall in no case be considered confidential:

- a) the total and unit prices stated in the bid;
- b) the subject of the procurement, or the offered goods, services or works upon which the comparison with the technical specification depends and the opinion that the bid is in accordance with the requirements of technical specifications;

c) evidence of the personal situation of the bidder (within the meaning of Articles 45-51 of the Law).

31. Amendments and withdrawal of the bid

By the deadline for submission of bids, the bidder may amend its bid and do it in a separate envelope with stating all the information contained in point 14 of the tender documents, namely:

The back of the envelope shall bear the following: Name and address of the bidder or bidders' group

Until the deadline for the receipt of bids, the bidders may give up their bids, by a written statement on their withdrawal of the bid, which shall mandatorily indicate the subject of the procurement and the number of the procurement, and deliver it no later than the deadline for receipt of bids.

The bid cannot be modified, amended, or withdrawn after the deadline for receipt of bids.

32. Ubnormally low bid price

In the event that the Contracting Authority has doubts that the bid prices are abnormally low it has the possibility to check the prices, in accordance with the provisions of the Guidelines on the method of preparation of the model of tender documentation and bids ("Official Gazette of BiH", no. 90/14), and request from the bidders a written clarification of the abnormally low bid price.

Upon receipt of the statement of reasons for abnormally low bid price, the Contracting Authority shall bring the decision and notify the bidder in writing.

In the event that a bidder refuses to provide a written explanation or submits an explanation from which it cannot be seen that the bidder will be able to deliver the goods at that price, such a bid may be rejected.

33. Legal remedy

The appeal is lodged to the Office of Appeals, by care of a Contracting Authority within 10 days from overtaking of the tender documents.
