Contracting Authority A.D. OC "Jahorina" Pale, pursuant to Article 64, paragraph 1 a), Article 70, paragraph 1, 2, 3 and 6, Article 71 paragraph. 1. The Law on Public Procurement of Bosnia and Herzegovina ("Official Gazette of BiH", No. 39/14), Article 65, paragraphs 1, 2 and 3 of the Public Procurement Statute of the Company, number: 650-OC / 15 from 26.02.2015. and the Minutes from the opening of the final offers of the Commission for Public Procurement of Goods, winter suits for OC Jahorina employees, number: 3135-OC / 19 from 10.06.2019. The Management Board of the Company adopts:

#### DECISION

on awarding the Contract

I

Offer of the bidder "**Kaama S.r.l. Italy**" shall be declared admissible and "**Kaama S.r.l. Italy**" shall be awarded the Contract for public procurement of goods, winter suits for employees of OC Jahorina, in the negotiation procedure without prior notice, for the needs of OC "Jahorina", Pale.

The contracting authority will notify all participants in the procurement procedure on the results of the analysis of the received bids in this procurement procedure in accordance with Article 71 paragraph 1 of the Law on Public Procurement of BiH and publish it on the Company's website.

By the validity of this decision, the Contracting Authority shall invite the selected bidder to conclude a contract that will regulate mutual rights and obligations for the procurement in question in accordance with the provisions of the Law defining the negotiated procedure without prior notice, requirements and conditions set forth in the tender documentation and legal regulations governing the procedures of contracting.

#### Explanation

By Decision of the Supervisory Board, No. 825-OC / 19 from 31.01.2019, the procurement of goods, winter suits for OC Jahorina employees is foreseen, through negotiation procedure without prior notice.

Procurement procedure was initiated by publishing information on the subject procurement procedure on the website of the Contracting Authority and by submitting a call for participation in the case procedure to the address of the only candidate.

Estimated value for public procurement of goods, winter suits for employees of OC Jahorina is BAM 140.000,00, excluding VAT,

The Public Procurement Commission was appointed by the Decision on the appointment of the Commission for the Public Procurement Procedure No. 2156-OC / 19 from 29 March 2019.

By Tender Documentation, number: 2157-OC / 19 from 29 March 2019, the subject of procurement, the qualifying conditions for participation in the procurement procedure in question and the award criteria were established.

By Insight into the Acts of the Public Procurement Commission and the acts of the bidders as follows:

- Invitation for submission of request for participation, number: 2157-OC / 19 from 29.03.2019
- Request for participation for public procurement, number: 2627-OC / 19 from 06.05.2019, the candidate "Kaama S.r. Italy";
- Minutes on the assessment of the eligibility of candidate's request for participation, number: 2683-OC / 19 from 06.05.2019,
- Decision on prequalification results, number: 2684-OC / 19 from 06.05.2019
- Initial bid number: 2851-OC / 19 from 20.05.2019,
- Minutes on the opening of initial bids, number: 2945-OC / 19 from 27.05.2019,
- Final offer of the bidder "Kaama S.r.l. Italy" number: 3099-OC / 19 from 07.06.2019,

- Minutes from the opening of the final offer with recommendation, number: 3135-OC / 19 from 10.06.2019

It was determined that the final bid from "Kaama S.r. Italy ", meets the requirements of Tender Documentation, number: 2157-OC / 19 from 29.03.2019. The total bid value is EUR 69.579,20, or BAM 136.085,09 excl. VAT.

Bearing in mind the aforementioned and recommendation of the Commission to award the bidder "Kaama S.r. Italy ", the contract for the subject procurement, it was decided as in the enacting clause of the decision.

By insight into the relevant documentation, it is established that the bidder has not submitted the evidence referred to in Article 45, paragraph (1), items a) to d) of the Law on Public Procurement, and it is obliged to submit it within 10 days from the date of receipt of this Decision.

Legal remedy:

Against this Decision, pursuant to Articles 99 to 101 of the Law on Public Procurement of BiH, a complaint may be lodged with the Contracting Authority in writing to the address: A.D. OC " Jahorina " Pale, Ruski Dom, Jahorina 71420 Pale.
